1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The college is based nearby the riverside of *Dudhganga*, a hilly rural area of Radhanagari *tehsil* in the Kolhapur district of Maharashtra. It is the only science college in the *tehsil*. Being the mountainous rural area, the students especially girls were facing many problems for higher education. Looking at this need along with the poverty in the area and to remove the inequities in access to education amongst various social groups, the foundation of *Sanstha* pillared under the competent guidance of Hon. A. Y. Patil *saheb*.

Shri. Vyanknath Shikshan Prasarak Mandal, Solankur was established in 1996. Starting with primary, high school, junior college of arts & science; the senior college was started in the year 2009 with the mission to sensitize the students to ethical, social and cultural values to make an enlightened nation and strive for mass welfare and happiness through spread of education. The college is committed to meet the educational and societal needs of the hilly rural area which will help to build up the humane nation under the skilled leadership of college Chairman Hon. R. Y. Patil *saheb*.

The most striking feature of the institution is the fulfilment of the founders' vision of to cater education to the masses with its vision to build enlightened and humane society by educating the children form deprived classes. The institution is permanently affiliated to Shivaji University, Kolhapur, and accredited for the first cycle by NAAC in 2017 with CGPA 2.14 with 'B' grade.

Institution as a co-educational, Government aided institution has completed 14 years of yeoman service. The institution has 20 highly qualified faculty members with 14 Ph.D., 04 NET/SET, who are experts in their respective fields discharging their duties with a sense of dedication and integrity. Institution offers 05 UG, 01 PG course with CBCS and NEP.pattern The institution runs various UG programmes such as B.Sc.Botany, Chemistry, Mathematics, Physics and zoology, 01- PG in Analytical Chemistry of Shivaji University, Kolhapur. Total 20 Add on/Skill/Certificate courses are also operational to enhance students' employability. The institution has adequate infrastructure and ICT facilities for effective curriculum delivery

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- 1. The Institution is affiliated with Shivaji University, Kolhapur, the College abides by the curricula and syllabi prescribed by the University for all 5 UG, 1 PG Programmes. For the smooth conduct of the teaching-learning process, a uniform Academic Calendar prepared aligned with all departments and faculty-wise Time Table is prepared by the Time-Table Committee which is then adopted after the approvals from the IQAC and the Principal. The timetable of internal examination is prepared and displayed on the website for execution.
- 2. Semester-wise Teaching Plans, and Syllabus Completion Reports are made according for the proper implementation of the curriculum. Different Pedagogies are adopted for effective curriculum delivery with Curricular, Co-curricular and Extra- curricular activities.
- 3. In every academic session, the IQAC and College Development Committee plans the college academic calendar with CIE for curricular, co-curricular and extracurricular activities. The departmental Academic plan/ calenders mention the sessional/internal examination schedules. The details regarding submission dates of assignments are informed by the individual teachers as per their lesson plans.
- 4. In various capacities and as members of their respective BOS, Faculty members participate in curriculum development and assessment at the University.

Academic Flexibility:

All the 5 UG are offered through the Choice Based Credit System/Elective course system (NEP 2020).
The college offered 20 ADD on Certificate courses focusing on the employability and skill development
of the students in the last five years. Total 633 students have enrolled in such courses during the
assessment period. The curriculum is enriched with certificate courses. Teachers have designed the
syllabi for Certificate Courses.

- The syllabi of 20 ADD ON courses address different skill oriented ethics, Professional Ethics, Gender, Human Values, Environment, and Sustainability in UG programs. The same is further integrated into the curriculum through effective delivery of the syllabus, extracurricular activities, and the College's policies.
- Students also engage in project work, fieldwork for supplementing the teaching-learning process. The students benefited from experiential learning through field trips/project work/internships in the assessment period.

Feedback system:

• The College has a systematic mechanism for collecting and analyzing feedback from students, Teacher, and Alumni stakeholders.

Teaching-learning and Evaluation

Student enrolment and profile:

- The admissions are given on merit basis by keeping in view of Vision of the institution and strictly as per guidelines given by State Government and University.
- The average percentage of enrolment is 77.56%.
- Total number of seats earmarked for reserved category is 50% as per GOI/State Government rules.
- To maintain the student-full time teacher ratio, management has appointed a required number of fulltime teachers for all the Programs.
- Student and full time teacher ratio is 15:1.

Catering to student diversity:

- Before the commencement of the academic year, Diagnostic Test is conducted.
- Slow and advanced learners identified by diagnostic test and extra classes conducted.
- Career counselling is offered for all learners.

Teaching-Learning Process:

- Blended teaching-learning methods including ICT and traditional classroom practices, Group Discussions, Industry Visits, field Visits and Expert Talks, conferences, workshops, seminars etc.,
- Participative, experiential and problem solving methods are used by faculty for student .
- To enhance the learning experiences, various student centric methods are applied by faculty viz. video lectures, PPTs, e-notes, question banks and subject-related e-books. Moreover, subject-related video clips, animated videos and You Tube videos have been used as learning resources.

Teachers' Profile and Quality:

- The Institution has more than 57% of well qualified full time teachers. Full-time teachers with M.Phil/Ph.D. and NET/SET are 14 and 13 respectively.
- The Average teaching experience is more than 6 years.

- Assessment is undertaken as per the Continuous Internal Evaluation (CIE) schedule.
- CIE is scheduled with two internal unit tests and assignment.

- Total 9 faculty members are recognized as a research guide and actively engaged in research, under these guides total 19 students are pursuing their Ph. D.
- Total 3 minor research projects were completed by faculty and 12 minor research projects are ongoing.
- 16 Workshops/ Conferences on Research Methodology, Entrepreneurship and Intellectual property rights.

- 25 research papers in UGC CARE listed journals and
- 24 Book chapters/ conference proceeding papers are published during last five years.

- 18 extension activities have been conducted during the last 5 years.
- The institution has NSS unit actively organizing extension activities. Institution work has been appreciated by nearby all Gram Panchayat due to extension work done towards social services.
- The Institution Organizes different awareness programmes through NSS, various committees and departments on Swachh Bharat Abhiyan, Disaster management, Gender sensitization, Tree plantation, Voting rights, Adult literacy, Cleanliness drive, Women empowerment, Health issues, AIDS awareness, Covid-19 awareness, Relief funds for victim affected peoples etc.

Due to hilly area, the college lacks the sufficient college campus. Still it has manageable area about 1.225 arcs. The construction of new building is completed by the management with the budget about Rs. 2.34 crores. About Rs 19 lakhs have been utilised to develop the laboratories. The faculty make use of computer, internet facility for ICT teaching-learning purpose. They prepare ppt's, download related videos. They use their laptops, LCD for effective ICT teaching-learning.

- The average budget allocation for infrastructure augmentation: 33.7 %.
- Adequate parking facility, Computer Labs, Library, Cafeteria, Common rooms for girls, Recreational spaces, Ramp facility for Divyagjan, electricity back up, CCTV, Gym etc. are provided.

All programmes will be designed in such a way that students will get maximum flexibility to choose elective courses offered by other Departments and MOOC through SWAYAM platform. It can be said that the Institution is proactively working towards implementation of the suggestions given in the NEP Guidelines. 2. Academic bank of credits (ABC): Our institution preparedness in implementation of Academic Bank of Credits confirms to the guidelines of the affiliated university. Shivaji University, Kolhapur being state university is an official member of the National Academic Depository which is a government endeavor to offer an online repository for all academic awards under the Digital India Programmes. From 2021 onwards University is in the process of student's registration through the nad.digitallocker.gov.in platform through its affiliated colleges. The University follows a choice based credit system (CBCS) for all its programmes and is now in the process to pass a resolution related to the ABC in the Academic Council. Institution will formally register in the ABC portal as soon as the resolution is being approved by the higher academic bodies. For this purpose, Institute is in the process of creating centralized database of the students. Through this database, where in the academic credits earned by the student from various courses will be digitally stored so that the credit earned by student previously could be forwarded when the student enters the program again. For monitoring ABC, proper technical support system will be created. 3. Skill development: The Institution conducts the skill oriented programs for overall development of students. The mission of the institution is promoting Skill Based Education and takes efforts to inculcate positivity among the learners. Mentoring students is also one of the practices of the institution, to enable students to explore future employment pathways after graduation, and help them get the most of their studies.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

The institution promotes the exchange of linguistic and cultural traits of heterogeneous groups. The examination of 1st year students for the semester I and II is conducted at institutional level and results were communicated to the University. As per Shivaji University notification, the institution has also taken examination for the Semester III, IV, V and VI for UG students and Semester I and II of PG students. The examinations of Civic Courses (Non-CGPA) twice in a year-for the first- and third-Year students were also conduct by the institution and results have to be communicating to the university within a specified period.

Examination committee looks into the grievances related to internal examination. The institution ensures effective time management in order to conduct various types of examinations. The havoc exposure of digital movement results in a positive impact in India. But it is already known that the digital knowledge of the rural students is lower than that of urban students due to lack of digital exposure and facility. Therefore, the students of the rural area suffer from many communication gaps in different sections. Consequently, in this digital age, they lag behind the other urban students. Shri Yashwantrao Patil Science College, Solankur situated in a rural area, has adopted various measures to raise the level of digital consciousness and competency of the

students to acclimatize them to the contemporary digital environment. With this objective in view, the college has established the ICT based teaching-learning system. ICT enabled classroom, seminar hall and lab make the mission of college authority successful. The ICT infrastructure of the college helps to maintain the entire education system fit and fine during the pandemic caused by Covid-19 when the students have been out of campus for a long time. During the Covid-19 pandemic, when digital platform was the only available connection between the students and the teachers, ICT tools were enormously used by the teachers of our college. Online live classes were conducted through different apps like Zoom, Google Meet, etc. Pre recorded videos prepared with the help of different screen recorder like Screencast-o-matic, free screen recoder, Free Cam, OBS studio etc. were widely used. Social media like WhatsApp, Youtube, Facebook etc. platforms were used to share various learning resources to the students. Besides, online exams were conducted through platforms like Google classroom, Google Quiz etc.

The teachers of our college regularly use ICT tools like computer and projectors in their classes and in their academic purpose. There are 22 desktops and one laptop available in the college and these are exclusively useful for the delivery of academic contents. 6 projectors with 5 numbers of ICT classrooms and 1 seminar hall which are used by the teachers for the smart classes as well as by the students for their seminar presentation. Xerox machine, printer with scanner etc. are available for academic purpose.

All the Departmental classrooms in the college are ICT enabled with projectors with screen. The college has its institutional official website. All the events conducted in the institution are displayed on the institutional website. The website not only highlights the achievements of the institution in the academic arena but it also enables the students to have easy access to various information and necessary links. College has its own YouTube Channel. The Practice:

As an attempt in this direction, member of nature club and students under the guidance of Co-ordinator teachers have been monitoring many environment conservative activities. One of the important activity carried out by nature club is cleaning of riverbank and riverside area after 'Ganesha Utsawa'. It is known that after 'Ganesh Utsawa' festival peoples immerses the Ganesh idols and release Nirmalya in river water which makes water pollution. Hence, the club member along with the students cleans such area by removing such immersed Ganesha Idols and Nirmalys from river and return it to vendors for recycling and reuse by repainting. Riverside areas were also dirty with full of garbage and waste which was collected and removed outside the river area by club members and students. Besides, tree plantation, nature conservation activities are also conducted by the Club.

Evidence of Success:

- After 'Ganesh Utsawa' club member along with the students cleans such area by removing Idols and Nirmalys from river and return it to vendors for recycling.
